• 2017 – **Preparing for action**





Five Steps to Action

- A new stronger climate law by Christmas
- A new Advisory Council in January
- Social Dialogue and Public Participation
- Five year carbon budgets by the Summer
- A new Climate Action Plan by the Autumn





Five principles for faster and fairer climate action

- Fairness
- Urgency
- Science
- Dialogue
- Accountability



What does faster and fairer climate action mean

From "A Shared Vision for A Just Recovery" launched on Monday by 60+ civil society coalitions and organisations:

A Just Recovery means focusing on climate justice, doing our fair share to achieve the goals of the Paris Agreement. It means eliminating climate-changing pollution in a way that tackles inequality and reduces poverty, and restoring and protecting nature and wildlife. Faster and fairer climate action can and should create thousands of new, well-paid, secure, unionised jobs across the country and support an economy that operates within ecological limits. It must include a Just Transition for the workers and communities most impacted by the move to a zero pollution future and must be fully equality and poverty proofed.

5 Tests for the Climate Bill



- 1. Does it put Ireland's 2050 net zero emission's target into law, and set it as the floor, not the ceiling, of our ambition?
- 2. Does it create a fully independent expert Council to advise Government and monitor progress?
- 3. Does it mandate Government to propose 5-year pollution limits that will be legally binding once adopted by the Dáil?
- 4. Will the 5-year pollution limits include all greenhouses gasses and all sectors of the economy?
- 5. Does the Bill provide for robust Ministerial accountability to the Oireachtas for keeping within the legally-binding pollution limits?



5 Weaknesses in the Bill



- 1. Pursue but not achieve! the 2050 target.
- 2. Must be net zero by 2050 at the latest
- 3. The Carbon Budget could exclude methane and nitrous oxide
- 4. The Carbon Budgets don't have to be line with the 2050 target
- 5. The Plans don't have to be consistent with the Budgets
